CDDO Updates/Reminders:

- Please be mindful of the CIT/BHU's time when deciding whether it's necessary to call them.
- All outreach/gatekeeping has to go through the CDDO. Contact Michelle.
- APS reporting: CDDO asked providers if they have been asking to be notified of substantiation
 when submitting APS reports, and whether they have been receiving them. One provider has
 experienced that they aren't always receiving notifications when they ask for one.
- Reminder for TCM's to complete CIR's when they are made aware of an incident. Remember CIR's are confidential, do not share them. Do not copy/paste someone else's CIR, you should be gathering your own information and writing your own CIR.
- See new/updated forms attached: Provider Service Denial Form, Agreement of Service Exit
 Protocol. See updated policies attached: 06-003 Uniform Access to Services and 06-013 Options
 Counseling, Referral, and Transition. Forms are available in BCI and policies are updated on the
 website.
- Reminder that the CDDO maintains an internal waiting list for individuals interested in a provider
 when that provider is closed to new referrals. TCM's notify the CDDO that someone wants to be
 added to the CDDO's internal waiting list by emailing servicechange@sncddo.org. If someone is
 just exploring options/touring, notify Coleen by email chernandez@sncddo.org.
- The CDDO is assisting KUCDD (KU Center on Developmental Disabilities) with their waitlist study survey. Randomly selected participants will receive a text with a link to take the survey. We'll give TCM's a heads-up if they have a person on their caseload who has been selected to participate.
- Medicaid Renewal Process if there are issues, the CDDO needs to be made aware so that we
 can assist. Corby Lockwood stated if providers are getting denials for payment, don't wait to
 reach out. There are some issues with the level of care being coded incorrectly, which is an easy
 fix if you reach out ASAP.
- KDHE has indicated that if there are specific issues regarding the Medicaid financial eligibility review process for someone you are serving, Latonya Palmer can be contacted at: Latonya.Palmer@ks.gov (cc: Yvonne Case at: Yvonne.Case@ks.gov). Make sure to include as much detail regarding the issues as possible (including name, date of birth, Medicaid number, etc.)
- Discussed the Community Support Waiver. Corby stated that it will be implemented in 2025.
- Discussed the statewide waiting list, hopefully more people will be coming off if funding is approved, capacity still an issue.
