Aetna is replacing Amerigroup January 1, 2019-Amerigroup members were sent a letter announcing the change. Medicaid members have been given the option to stay on with Aetna or change over to Sunflower or United and have until 4-3-19 to decide. Services will be as continuous as possible, keeping in mind until that 1-1-19 date, Amerigroup is responsible for all claims. Aetna has member services, call center and website up and active. Affiliates need to remember to enter into a contract with Aetna, current one with Amerigroup will not roll over. Affiliates need to obtain a KMAP number by 11-1-18 and need to be in touch with Aetna ASAP. Aetna will provide I/DD experts as team leads whom Case

Managers and Affiliates can contact day or night. Aetna discussed Positive Behavioral Supports as an initiative they are attempting to implement. ACT team consultants are working with KU. One contact person for all access to I/DD team and team lead, this is the system of care for both adults and children. Each person will have one Service Coordinator, I/DD team lead. Town Hall meetings, once a month innovative lunch series', and Roadshows will start to take place in late October to the end of November. Aetna promises lots of resources to help this transition and hands on learning on how to use their system and materials. There is a \$500 dental benefit to Aetna members. Aetna is working on being able to utilize \$5,000 grant for those in nursing homes that could get back into the home with modifications to the home, personal, and respite care. Aetna is actively trying to hire.
