Introductions

Guest Speaker:

Matt Enyart, Kansas Institute on Positive Behavior Supports. Matt gave an overview of his work in Positive Behavior Supports, including development of standards for DSP's and being a part of the Challenging Behavior Workgroup. He has had success working with providers in Johnson County implementing PBS within organizations. There have been many benefits, including a drop in worker's compensation and turnover, which in turn benefits the individuals served as well as the staff. Matt is now writing a grant to continue his work in Shawnee County. Matt opened the discussion up for feedback from affiliates and challenges mentioned were the difficulty of collecting data for behavior tracking, staff retention and training, and the complexity of medical care for individuals served. If we move forward we would send out a survey asking for input from all affiliates as this should be a "collaborative construction". Matt is proposing what would probably be a 3 year plan, with additional planning for future sustainability.

- Last meeting, we had a question about an MCO asking TCM's to use an incorrect billing code. We received a response that "the TCM should bill 99 (other) or 12 (home) instead of 11."
