- Masks: Surgical masks are better protection than cloth masks. Cloth masks should be 3-ply if possible and washed daily.
- Surgical grade mask and face shield worn together is considered full PPE. It's
 important to know that PPE only protects the wearer, it does not protect any
 persons the wearer is in close contact with.
- Close contact is considered within 6 feet or less, for a cumulative time of 10 minutes or more within 24 hours.
- Isolation = for a person who is symptomatic or positive, 10 days.
- Quarantine = for a person who has been exposed and is asymptomatic, 14 days. However, quarantine can go on longer if they are a household contact, based on when the symptomatic person recovers. See guidance:

- We have not seen in SNCO cases where people are being re-infected. CDC guidance is that people who have recovered can interact with others for 90 days as long as they are asymptomatic. But they do need to continue to use all safety precautions.
- Gatherings: While they are strongly discouraged, it is not always possible. Individuals need to evaluate their own level of risk to make a decision on gatherings. Remember that your decisions can affect people way outside of your direct circle. People are discouraged from gathering with people outside of your normal circle when possible.

CDDO Updates/Reminders:

- Tracing Assessment: Complete for contacts 48 hours prior to symptoms/testing
- Persons should quarantine for 14 days if close contact with a positive case.
- The SNCO Health Department is following the 10 minute guidance from KDHE.
- Group gathering/holidays: We encourage you to stay within your own group as much as possible
- PPE inventory: Providers need to stay on top of keeping an inventory. Looking online is the best option. Order supplies early knowing there will be shipping times.
- If a person is being tested, the CDDO needs to be notified right away. If positive the provider needs to submit tracing right away.
- If positive, complete a CIR/AIR. We want TCM's to complete them.
- Affiliate Agreements are due 11/15/2020.
