Derik reviewed the CDC updated quarantine timelines for healthcare workers and for the general public. When CDC guidance comes out, the county typically waits for the state before implementing guidance. The State can choose to adopt or not adopt CDC guidance. The County can choose to adopt or not adopt CDC or State guidance.

Rapid Antigen tests are best. The PCR can still flag as positive the person had previously been positive in the last 90 days. The Rapid Antigen tests do not flag as positive if the person had previously been positive.

Where to get COVID tests? The Health Department is working on updating their site with this information. The Health Department no longer has antigen tests to hand out.

Differences between KDHE and SNCO guidance:

- KDHE guidance allows for positive staff to return to work during their infectious period if they will be working only with other positive persons. SNCO is not adopting this.
- KDHE defines an exposure as within 6 feet for 15 minutes. SNCO is going by 6 ft for 10 minutes.

Dr. Locke considers <u>D</u>ay and Res providers as congregate settings.

For staff who go to a home that is not a congregate setting, we will follow up with guidance from Dr. Locke.

Administrative staff or staff not working with individuals are considered general public.

Any variant before Omicron does not protect against Omicron. Omicron is protective against any other variant. This could differ person to person.

Dr. Locke on references to Omicron being "mild": Omicron is less severe than Delta but more severe than the original COVID.

Even if the percent of hospitalizations is low, we are still seeing hospitals at capacity because of the sheer number of cases.

There is currently no expiration on the booster. We are not sure yet if the booster will be needed annually.

Hopefully this spike will run its course in the next 3-4 weeks. It should either plateau or drop off in February.

Tracing and why it is important: One person with Omicron will infect 10 more people. If we can prevent even 1 person out of 10 from getting it, we consider that a success.

The test does not tell you what variant you have. Genome sequencing can be done to determine the variant. If you test positive at this point in time it is a sure bet that it's the Omicron variant.
