CDDO Updates/Reminders:

- Discussed EPSDT services, TCM's should be looking into this for those on their caseload who would qualify and benefit. Elizabeth Barkley shared some of the difficulties her TCM's have run into while trying to get access to EPSDT. We are working on scheduling a training with DRC. ([See EPSDT Guide attached](#))
- CDDO Core Trainings will be IN PERSON 11/3/22 and 11/8/22. Robert is going to be adding a Crisis Funding Request Training.
- Address information changes with KDHE: The CDDO can no longer report contact information changes, it has to be done by the individual or the guardian. ([See KIERA flyers attached](#))
- PAS Tools need to be completed once a year. If your individual has multiple providers, rotate through providers so you are doing a PAS tool on a different provider each year.
