- Shawn Killian, KNI. Gatekeeping is the same process as Parsons but KNI doesn't have a school
  and doesn't generally admit persons under 18. Outreach sedation dental and labs available.
  Behavior outreach provide ongoing support, meetings with the team for problem solving.
  Contact Shawn to schedule a tour. KNI no longer has a medical unit, no direct admissions from
  the hospital. No longer providing respite.
- Authority to Admit is needed for individuals 18 and over, per Kansas guardianship law.
